9. Age Group Secretary's Report

Level 3 Meet

Closing date Monday 24 June.

Level 2 Meet

License granted.

As suggested at the previous meeting we need to amend the programme to 7 sessions. The Squadrons will be on Sunday 20 October in the afternoon i.e. it will be listed as session 8.

Suggested closing date for the Age Groups Monday 9 September.

Swim League Report</p> <p>Mary advised that the Round 2 results and League Tables were on the website together with the Lane draws/club duties for the third round at Blackpool on Saturday 1st June 2019. She thanked Jane Whittle for her help in booking venues this year and Bob for his support.</p>	
<p>11. Development Committee Report</p> <p>BT read the following e-mail from Steve Heaps, who had sent his apologies to the meeting, owing to coaching commitments</p> <p><i>Please accept my apologies for non-attendance at tonight's meeting. My personal circumstances have again changed and this should allow me the time to try and concentrate on this subject a little more now as I have been able to do in the past 12 months. It is my intention in the next couple of weeks to try and email all Head Coaches in the district and to arrange a meeting for coaches at the Development meet in Blackpool on 13/14 July. I hope to have an agenda put together for the development meet which will be sent out prior to the competition.</i></p> <p><i>Please accept my apologies for lack of communication over the past 12 months.</i></p> <p>All acknowledged Steve's valuable input to date and passed on their condolences on the recent death of his father.</p> <p>BT raised the possibility of mentoring of junior coaches by senior club coaches at the Level 3 meet in July and running a further stroke clinic with Michael Rock</p>	<p>SH</p>
<p>12. Handbook/website</p> <p>BT & ST to meet regarding trophies in advance of autumn Championships.</p>	<p>ST/ BT</p>
<p>13. A.O.B.</p> <p>Summer Regionals</p> <ul style="list-style-type: none"> • There was an extensive discussion concerning the forthcoming Regional Summer Championships concerning the tighter QTs, timing of the dissemination of information and adoption of online entry system. • BT distributed the table in Appendix A which compared the 2018 Championship results with the 2019 QTs and which he had forwarded to the Region and which predicted reduction in the number of entries. Whilst it showed a 33% reduction overall there were wide fluctuations in the reduction across age groups, events and distances with two events showing a predicted two-thirds reduction in entries.

<ul style="list-style-type: none"> • The 11/12-years age group showed a disproportionate reduction in predicted entries compared to other age groups and BT cited examples of swimmers from Preston & Southport who had medalled at the 2019 County Championships but who were ineligible for entry to Regionals, because of the tighter times. • Concern was expressed that, if 11/12-year old were not encouraged at this level of the sport, they would not remain in the sport in later years to develop at National Level and above and the base of potential talent would shrink. • BT also compared the NW entry times with those for other Regions and demonstrated that the NW Region had significantly harder QTs than other Regions. • BT also highlighted the SE Region entry system which had an automatic QT together with an easier consideration time (CT) and where available pool time is filled up from swimmers having achieved the CT, fastest first. This contrasts with the NW where there is no discernible, transparent system for fairly allocating available pool time across age groups and events and providing a level playing field and equal opportunity for all. • JW advised that coaches had requested that the QTs be tightened following the 2017 Champs which were regarded as too long. She advised that the Region had consulted coaches on the new times and not received any adverse comments. None of the delegates were aware of any consultation. BT advised that Gill Rankin had volunteered to consult on the QTs but had not been contacted prior to publication. • JR expressed surprise that QTs were being tightened at a time when the quality of swimming on the face of things appears to be declining, not improving which would naturally necessitate a raising of the bar. • Concerns were also expressed about the difficulty and additional cost of obtaining poolside passes under the National online system, given the short period between publication of the entry data and the event. • It was agreed by 10 of the 11 clubs present that the secretary write to NW Region outline the above concerns and requesting a wholesale review for future years.
