I am attending a meeting of the Associations soon to discuss various issues arising from the change to licensed meets and how it will affect the competitions we run.

I will also be calling the swimming committee together to discuss our plans for the various competitions so that we cater for all our swimmers in North Lancs.

I am in the process of booking a pool for the October meet. This will probably not be held at Blackpool as there are prior bookings!

It is possible that the meet will be held at Fleetwood. The hire of Fleetwood is very reasonable at £60 per hour. We can't have Saturday morning so it would be afternoon and evening on the Saturday and morning and afternoon on the Sunday. The draw back with Fleetwood is the spectator area as it is quite limited.

I have also made enquires at Salt Ayre but to date have not received a reply.

If it is agreeable I will book the facility which is available.

ST proposed that the amount given to clubs for teaching courses be increased. GW seconded and all present agreed. This will now be as follows

Each club can apply for funding up to £600 each year. To be used as follows:

L1 £75 L2 £150 L3 £300

It is hoped that this will help the clubs increase their qualified staff.

Clubs can apply for funding in writing when the course has been completed and a pass certificate has been received.

Any funding application to be sent to the Secretary.
