### 1. WELCOME

## 8. SUB COMMITTEE REPORTS

### • Age Group Report

The Level 2 Competition had been a good meet, there were fewer competitors but the feedback had been good, some things need to be looked at for next year. The sessions were a good length with no major issues. J Whittle thanked the clubs as all clubs provided volunteers. There was a full quota of officials and mentoring was able to take place so thanks also to these and the Timing Suite and Announcers; new people were now interested in these roles.

Dependent on pool availability provisional dates for next years' competition are the 1<sup>st</sup> and 2<sup>nd</sup> and 15<sup>th</sup> and 16<sup>th</sup> October with entry fees to be £4 and Squadrans to be run in Session 8.

## 11. Handbook/Constitution

- iii. The draft is now to go forward to AGM for adoption, subject to final ratification by NW Rules Group (post AGM).

The President advised that the constitution provides for the Welfare Officer to be appointed by the Executive. Whilst it provides for the Officer to keep the Executive informed of all matters relating to welfare this is read in a general sense without any requirement to provide specific detail of individual cases, where the officer is bound by the ASA code and guidance in these matters.

Changes to the Constitution proposed by Andy Gaskell and seconded by Kevin Whiteside and agreed by all present.

## 12. ANY OTHER BUSINESS

**Masters** – Janice Whittle advised that at the ASA Masters in Sheffield Sophie Casson broke the British, European and World Records in the 30-34 age group in the 400m freestyle. The President pointed out that she still holds several Inter-Association records.

**Trophies** – Sue Tinkler has taken the bases to look into the manufacture of new ones. This is ongoing but should be done by the time they're needed, a gentleman has offered to do them for the cost of the materials. The Ladies 100m breaststroke trophy needs to be valued as the replacement cost would be very high. The President suggested selling the trophy because it is, very large, quite delicate and impractical for most recipients. The money raised could defray the costs of refurbishing the remaining trophies. He suggested we defer any decision until the valuation is to hand. Two of the league cups are back and the League trophies will be presented at the AGM, together with the Bob Marshall Trophy to the Championship winning club.

## NLSWPA

### Hon. Treasurers Report 26<sup>th</sup> October 2015

Accounts for year ended 30.09.2015

- Since the last meeting the accounts for the year ended 30.09.2015 have been finalised and sent to John Armour for his independent review
- The accounts are as circulated and the only difference from the figures reported at the September Exec meeting were :
  - Additional expenditure for the Swim Camp £43
  - Postage £8
  - Bank interest received £5
- The net deficit for the year was £2,791
- Bank and cash reserves at the end of the year stood at £34,884.
- Whilst the Level 2 meet started in the last week in September it was agreed to exclude any income or expenditure in connection with the meet from the accounts, so that each year's accounts reflects only one Championships.

The accounts for the month of October 2015 have also been circulated.

- These include the Level 2 meet which generated a surplus of £1,824, subject to the pool hire charges estimated at £5,100.
  - This is well down on the Level 3 meet in January which produced a surplus of £9,277
  - Entries were down by 33% on the Level 2 meet – partly a reflection of the higher entry standard.
  - Spectator fees were down by a similar percentage.
  - Costs were relatively static, with the exception of the badges, which are more expensive than the medals and the higher levy paid as a level 2.
  - If the Association wishes to continue to support its member clubs through Bursaries and the Swim Camp, in the future it will need to generate a higher return on the meet.
  - The Swim Committee have looked at a number of options including raising the entry fee, moving the date of the meet and possibly easing the lower QT. These will be covered in the Committee report.
- The only other expenditure in the period are the three bursaries paid out to clubs as detailed in note 5 totalling £1,195.
- The Association currently has £40,613 in reserves, with a pool hire bill due to B/Pool Council outstanding and estimated at £5,100.

Again I would just remind clubs that If you are making a BACS payment to the Association, for subs entries fees etc., could you please ensure that you also e-mail me a remittance advice to advise me of the amount being paid, so that I have a record of the amount coming in, rather than having to wait for the bank statement to arrive?
